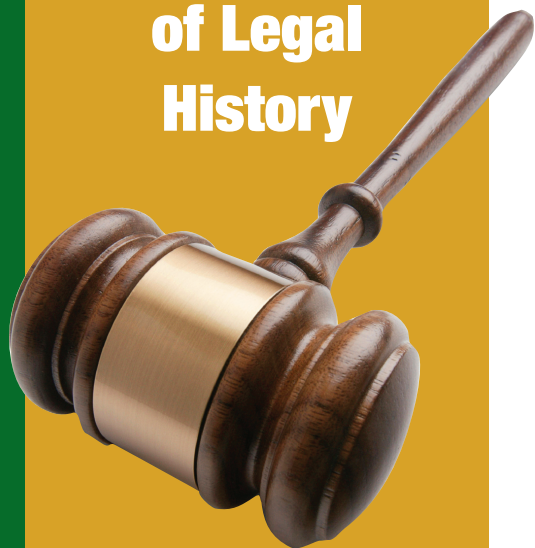

*Index to Legal Periodicals Retrospective: 1908-1981* indexes over 770 legal periodicals published in the United States, Canada, Great Britain, Ireland, Australia, and New Zealand. Annual surveys of the laws of a jurisdiction, the federal courts, yearbooks, and annual institutes. Annual reviews of the work in a given field or on a given topic are also included.

- Nearly 600,000 records, including book reviews and case citations.
- Includes contents notes—for special issues and symposia. Each individual article and author are identified.
